3. **Compose a 750 word essay on the Credit and Collection Industry and this must be attached to this application.**
4. **Transcripts must be attached to this application.**
5. **The MCA Personal Finance Education Scholarship funds will be sent to the College in which the student attends which will require proof of enrollment and attendance in the College prior to disbursement.**
6. **The name and contact information for the College of choice.**
7. **All applicants must be current residents of the state of Missouri and citizens of the United States.**
